It is with deep sadness that I advise you of the death of our beloved Sir Knight Sid C. Dorris III, GCT, Right Eminent Grand Generalissimo.

Sir Knight Dorris served as Right Eminent Grand Commander of Tennessee in 1994 and was appointed Right Eminent Department Commander of the Southeastern Department for the 63<sup>rd</sup> Triennium. He was elected Right Eminent Grand Captain General on Tuesday, August 15, 2006, in Houston, Texas, and elected Right Eminent Grand Generalissimo on Tuesday, August 18, 2009, in Roanoke, Virginia.

Sir Knight Dorris laid down his sword and entered the Supreme Asylum above on Friday, November 19, 2010.

It is my order that the Charters of all Commanderies under the Jurisdiction of the Grand Encampment be draped in Sir Knight Dorris' honor at their next Stated Conclave following receipt of this notice. The Charter is to remain draped until the following Stated Conclave.

I further direct that the Charters of all Grand Commanderies under the Jurisdiction of the Grand Encampment be draped in Sir Knight Dorris' honor during their Annual Conclave.

Each Commandery and Grand Commandery is expected to pay appropriate tribute to Sir Knight Dorris at their annual Memorial Service. Please remember Sir Knight Dorris' family in your prayers.
